

Turn off the power at the circuit breaker before installing the dimmer.




- Risk of Electric Shock - More than one disconnect switch may be required to de-energize the device before servicing


WIRING DIRECTIONS

- 1. Insert the HOT wire to the dimmer's HOT terminal.
- 2. Insert the LOAD wire to the dimmer's Load terminal.
- 3. Insert the GROUND wire to the dimmer's GROUND terminal.
